

Andrew Faulkner: Painting with a sense of place

As a child I celebrated coloring outside the lines. Those loose imperfect marks define my gestural painting style to this day. With a focus on abstract landscapes and architectural interiors, my art is influenced by the vibrant colors of my Northern California surroundings. Many of my landscapes use what I call an "invented color space" where color is used to break up the composition and achieve a sense of depth and atmosphere that can be open to the interpretation of the viewer.

Born into a family of artists, designers, and architects, my paintings fuse the structural sensibilities of my architect father and the often riotous color sense of my interior designer mother. I studied painting at Trinity College with colorist George Chapman who was a student of Joseph Albers and learned the art of defining space with color and value. After 30 years of success in the graphic design field, I decided to get a real job and become a painter.



"Barnside" (diptych) • 40" x 71" • Oil on canvas






"Sea Birds" • 60" x 72" Oil on canvas


